3.2. Mixtures:

Description: Calcium sulphate (CAS number: 7778-18-9) roundcoated with cardboard and containing additives for strengthening and durability and glass fiber for the increased fire protection. Mixture of calcium hydrates with different hydrate level.

The product does not contain any substances which considered as hazardous, or the concentration of hazardous substances does not reach the extent stated in the relevant regulations, therefore it is not necessary to indicate them in the safety data sheet.
